## Central 4D Barrel Racers Oklahoma Mail-In Entry Form

- To enter a Central 4D Barrel Racers Oklahoma Region barrel race by mail, complete the attached form and send it, with a personal check or money order for the appropriate entry fees, to:

- Mail-in entry with all appropriate fees must be **RECEIVED** no later than the **Friday one week prior** to the event specified.
- There are a limited number of exhibitions available. They will be limited to three (3) per person or one (1) per horse entered. If you prepay exhibitions, you must be there when exhibitions start. **NO REFUNDS ON PREPAID EXHIBITIONS.** If all pages fill up and you do not get your exhibition, you will be refunded your exhibition fee.
- The draw numbers for all mail-in entries will be posted on the Central 4D's home page on the Thursday prior to the event.
- If you mailed in an entry and your name is not listed in the draw on our website, it is because we did not RECIEVE your entry by the deadline. If this is the case, you will have to enter on site the day of the event. Books are open for on-site entries starting approximately 1 hour before the exhibitions and will close after the first horse runs. **On-site entries are cash only!**
- Youth and Open entries will be drawn together, and times will be separated into respective classes. Senior Side-pot entries must also enter the Open class.
- We understand everyone has time conflicts and that everyone has a good reason for to request a special draw. However, due to the large number of "special requests" we are simply unable to accommodate *everyone* and therefore cannot consider *anyone's* request for an early draw.
- Once your mail-in entry has been received and your number has been drawn, you (or a representative) may draw out and get a refund up to 3hrs before the start of the race. No Cash Refunds will be given at the race. You MAY NOT substitute riders or sell your entry to someone else, however, you may have someone draw you out and apply your fees to their run. (A new number will be drawn for them at that time).**
